- 1. That Doon Valley Public School Society is a registered Society under the Societies Registration Act 1860.
- 2. That the Doon Valley Public School Society under Section 8 is of Non-Propriety Character
- 3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of the income from the institution is being and will be diverted to any individual in the Society/School Managing Committee or any other person/entity. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to the developmental, depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5. The school is not paying any charges towards using name, motto, logo or any other non-academic activities to any institution, organization or body.
- 6. That the school will not open classes under CBSE pattern, particularly classes IX/X/XI/XII and will not use the CBSE name in any matter whatsoever without obtaining the corresponding affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination bylaws, directions issued from time to time and the law of the land.
- 8. That the school ensures compliance to all statutory requirements like EPF, ESI and Labour laws etc. with respect to the school and staff of the school.
- 9. That the school will ensure that the Building safety, Fire safety, Water safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
- 10. That the school will ensure that sufficient number of qualified teachers are available as per the provisions mentioned in the affiliation bylaws before starting classes.
- 11. That the school will follow the provisions related to fees contained in the affiliation bylaws and will disclose the details of the fees to the students and parents every year before start of the session without resorting to any hidden charges in the heads of the fee.
- 12. That the school will not coerce any student/parent to buy books/stationary/uniform from any particular shop.

- 14. That the school will ensure that the school fulfils all essential requirement before applying for affiliation and will fulfil all other conditions post affiliation and comply with all general rules as given in the affiliation bylaws or notified from time to time.
- 15. That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the school has complied with all the conditions contained in the affiliation bylaws along with general rules.
